### **DISTRICT AND PARISH COUNCIL ELECTIONS**

2018 will bring the end of the four year term for serving Parish Councillors. Existing Councillors will be required to step down and if they wish to, re-stand for appointment at the Parish Council elections in May. The elections are due to be held on 3 May, along with District Council elections. Nominations forms for candidates are available from the Clerk or from: elections@scambs.gov.uk Completed forms should be returned by hand to South Cambridgeshire Council's offices at Cambourne, no later than 6 April 2018.

#### **CONNECTIONS YOUTH CLUB BUS**

The facility is parked on Haslingfield recreation ground car park Wednesdays 1600 -1800, during term time. Sessions are free to school Year 7 children. The council believe the facility offers an invaluable youth amenity for the area, awarding a £1,000 towards running costs. Please do encourage your children to go along, to help keep it viable.

**Cycle path** - interest for a cycle route between Harlton and Haslingfield and Wimpole to Cambridge has been lodged with the Greater Cambridge Partnership, Greenways project team

**Clunch Pit Woods** - the council are now working on a plan for the ongoing management of the area and safety inspections, including the trees on the Glebe.

**A603 Wheatsheaf junction** - A Local Highways Initiative (LHI) grant application has been made jointly with Eversden Parish Council for a Safety audit and design study for A603 Wheatsheaf junction

#### PLANNING IN THE VILLAGE

South Cambs District Council (SCDC) has granted outline planning permission for erection of two dwellings on the site of 26 Haslingfield Road; a decision is yet to be determined on High Street, Burnt Farm development for the erection of six dwellings. Prior approval for an extension to the existing grain store in Washpit Lane was given in December 2017. The parish council have been made aware of a proposal to submit a formal planning to further extend the existing grain store to accommodate all required grain storage at the one site.

#### FINANCIAL UPDATE

The precept request for 2018/19 is £8,500. This remains the same as the previous year. General reserves are healthy, however significant expenditure is allocated for village hall window repairs.

The councils Governance and audited Accounting statements for Year Ended March 2017 are published on the village website, or a copy can be obtained from the clerk.

Open Space and Facilities contribution monies (S106) received from South Cambs District Council (SCDC), payable from new housing development in the village 2014-2016 was allocated to the tree safety works in the Clunch Pit, the village pump restoration, two replacement community benches, and stone lintel repairs on the hall.

#### PARISH COUNCIL MEETINGS

Council next meet is Tuesday 27 March, in the village hall. All members of the public are invited to attend. There is a short session at the start of the meeting for public question time where you are invited to raise issues or questions. Meeting dates and agendas are published on the village notice board and village website.
